PURPOSE

AWARDS

Our first annual scholarship will be awarded to one individual applicant in 2019. The total award for the scholarship will be \$500.

ELIGIBILITY REQUIREMENTS

Scholarship applicants must:

- Be a U.S. citizen or permanent resident
- Must be a full-time student attending or planning on attending an accredited community college or four-year institution
- Graduate students may be full or part-time
- Must have received injuries from an accident involving a truck at some point in your life.
- Must have a minimum 2.5 GPA

APPLICATION MATERIALS REQUIRED:

- Submit an essay no less than 800 words and no greater than 2000 words in 12pt font describing how you overcame your truck accident injury.
- Submit a copy of the police report.
- Submit a copy of your most current academic transcript.
- Submit other relevant accident and injury proof.
- Submit your application prior to June 1st, 2019.

THE AWARD PROCESS

Our selection will be based on the strength of submitted application and also take into consideration how well the applicant has overcome the obstacles relative to a serious truck accident injury.
